## Whistleblower In Fear For His Life Comes Forward After Giving DOJ Damning Evidence Of Big Tech 'Tampering With Elections' To 'Overthrow The United States'

Recent court rulings against both <u>Facebook for their use of facial</u> <u>recognition software</u>, and <u>Google for their bias against conservatives</u> <u>in the workplace</u>, along with the Federal Trade Commission (FTC) Chairman Joe Simons openly <u>discussing the possible need to</u> break up companies like Amazon, Facebook, Google, and Apple as their antitrust investigations into those companies continues, topped off with the Trump administration <u>preparing to share up to 15,000</u> <u>complaints of political censorship by social media and big tech with</u> <u>the FTC</u>, all pales in comparison to what a Google whistleblower just handed over to the Department of Justice (DOJ).

#### **ELECTION MANIPULATION AND INTERFERENCE BY BIG TECH**

While the media continues to claim that big techs bias against conservatives, shadow banning and censoring conservatives, is just a "conspiracy theory," a Google whistleblower recently turned over 950 pages of internal documents, along with a laptop, to the DOJ, showing that not only is the censorship real, as well as blacklists and other methods of manipulating search results, but proof that the practice is being utilized for the direct purpose of manipulating the outcome of U.S. elections.

The whistleblower that turned over the documents and the laptop to the DOJ was a full time Google employee who previously had spoken to Independent investigative journalist Sarah Carter and to Project Veritas, providing the documentation that he had been collecting from internal searches that only full time Google employees had access to.

Before going public with his identity to Project Veritas, which will be shown a video embedded below, he had previously offered up some details to both Project Veritas and Sarah Carter. Carter details of her discussion with him before Project Veritas released their video interview where the employee, Zachary Vorhies, detailed what the documents proved.

We'll start with Carter's article titled "Exclusive: Google Insider Turns Over 950 Pages Of Docs And Laptop To DOJ."

"I honestly think that a free market can fix this issue," he told this reporter at a meeting in Washington D.C. "The issue is that the free market has been distorted and what's happened is that the distortion is so grotesque and the engineering is so repulsive, all we need to do is just expose what's going on. People can hear that it is bad but that can be bias. But when they see what Google has actually written with the documents, this will actually be taught in universities of what totalitarian states can do with this type of capability."

"It will be so revolting that it doesn't matter what the solution is, a solution will just form as a reaction to this manipulation they have done," the Google insider said. Read the entire piece over at <u>SarahCarter.com</u>.

Another Google insider had previously revealed the bias of of the company to Project Veritas, but didn't have the "smoking gun" to prove it, but the information and documentation Vorhies turned over to not only the DOJ, but also to project Veritas, who <u>published the</u> <u>documents in downloadable form so that everyone could see the</u> <u>evidence</u>, is most definitely a smoking gun, along with the bullets, and Google's fingerprints, since they came directly from their internal servers.

One specific key quote from Vorhies to Project Veritas encompasses how sinister Google's manipulations really are:

"I gave the documents to Project Veritas, I had been collecting the documents for over a year. And the reason why I collected these documents was because I saw something dark and nefarious going on with the company and I realized that [they] were going to not only tamper with the elections, but use that tampering with the elections to essentially overthrow the United States."

Project Veritas provides all the documents for download, saying they did not rename any of the files, but did separate them into downloadable folders, so anyone that wants to read through the information that was handed over to the DOJ, can go to the Project Veritas website, <u>scroll to the end of the article about this and</u> <u>download what they want</u>.

The folders are named Censorship; Fake News; Leadership Training; Partisanship; Politics; Hiring Practices; Machine Learning Fairness; Psychological Research; Misc and Video, and a; Everythingzip file. gz-police.png

#### HOW FAR WOULD THEY GO TO SILENCE THE WHISTLEBLOWER?

As Vorhies explains in the Project Veritas video below, after his first interview with them, where he was kept in shadows as to not be identified, he was immediately outed on social media as the "leaker," by someone he believes works for Google. He received a letter of demands from Google, which he complied with, to the point where he honestly told them he had turned over his documentation to law enforcement.

Then Vorhies was targeted with an intimidation campaign after he made it clear that he had activated a "dead man's switch," meaning in the event that anything happened to him, all the documents would automatically be released.

Via Project Veritas:

After having been identified by an anonymous account (which Vorhies believes belongs to a Google employee,) on social media as a "leaker," Vorhies was approached by law enforcement at his residence in California. According to Vorhies, San Francisco police received a call from Google which prompted a "wellness check." Vorhies described the incident to Project Veritas:

"they got inside the gate, the police, and they started banging on my door... And so the police decided that they were going to call in additional forces. They called in the FBI, they called in the SWAT team. And they called in a bomb squad."

"[T]his is a large way in which [Google tries to] intimidate their employees that go rogue on the company..."

Partial video of the incident was provided to Project Veritas. San Francisco police confirmed to Project Veritas that they did receive a "mental health call," and responded to Vorhies' address that day.

Vorhies states in the video that it is his belief that Google was laying the foundation to claim he was mentally ill or otherwise unbalanced, most likely to claim that his testimony was nothing more than a "conspiracy," which is ultimately why he decided to dump the entire treasure trove of documents so they could be released to the public, so that it wasn't just his "word" against Google's, but actual evidence that the general public can now access in full.


### **BOTTOM LINE**

Big tech is being targeted in the courts, with multiple lawsuits, including one against Google from Democrat presidential hopeful Tulsi Gabbard, <u>where she is suing them for \$50 million citing</u> <u>"censorship"</u> of her campaign after one of the Democrat debates.

The FTC is actively investigating multiple big tech companies for violating anti-trust laws, and the possibility of breaking them up is definitely one of the options being considered.

Congress is looking at them for a variety of issues, including the privacy violations and scandals Facebook has been engulfed in for the past couple of years, as well as Facebook, Twitter and Google's political censorship practices. Now that these documents are public, it will be much more difficult for Google officials to deny their "nefarious" practices the next time Congress hauls them before one of their committees.

ANP recommends watching the entire Project Veritas interview with Vorhies. His testimony is chilling, especially when he discusses his fear of retaliation and why he decided to release everything and reveal his identity to the public in hopes that it would offer him some protection.
